Temporary Competition Number (TCN), replacing Listing: TCNs will replace the current system of entering events with "listed dogs", and will allow dogs to temporarily participate in CKC events while they pursue permanent registration or an Event Registration Number (ERN). The current TCN fee is \$12.00 per trial (i.e. per dog, per day). https://www.ckc.ca/en/News/2021/March/TCNs-What-Are-They-And-How-Do-You-Get-One

**Event Registration Number:** All dogs that are foreign born and foreign owned require an event registration number (ERN) to enable them to be awarded titles by the CKC. Dogs may be entered as "listed"; however, an ERN must be obtained within 30 days of obtaining points, awards or scores to avoid cancellation. Application forms may be obtained from the Field Trial Secretary.

**Non-Member Participation Fee**: An annual fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee. In order to protect the awards/titles earned, the non-member will have the option to become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in all awards and titles being cancelled. NOTE: it is less expensive to become a CKC member than to pay this fee each year!

National Open Champion: The winner of the National Open Championship Stake will automatically become Field Trial Champion (FTCh) and is also entitled to be designated "National Open Spaniel Champion" (NOSC). CKC Sporting Spaniel Field Trial Rules & Regulations, Section 12.1.2.

Eligibility: The dog declared the winner of the last National Open Championship Stake shall be invited to compete in the stake. Pursuant to this regulation and until otherwise ordered by the Board of Directors of The Canadian Kennel Club, entry of dogs in this stake shall be confined to the following: (a) A dog which has placed 1st, 2nd, 3rd or 4th in an Open All Age Stake (including a previous National Open) at a CKC approved trial held under these rules hosted by a member club in good standing with the Canadian National Spaniel Field Trial Association (CNSFTA) will be qualified for the following 2 National Open Championship Stakes. (b) All dogs which have previously won this Stake. CKC Sporting Spaniel Field Trial Rules & Regulations, Section 12.1.4. All dogs previously qualified for the 2019 National Open are also eligible, by special ruling of the CKC.

- 12.2 Eligibility for 2021 (10-04-21)
- 12.2.1 Any dog qualified for the 2020 National Open Championship shall be qualified for the 2021 National Open Championship.
- 12.2.2 Any dog that has placed 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup>, or 4<sup>th</sup> in an Open All Age Stake at an AKC approved trial in 2021 will be qualified for the 2021 National Open Championship Stake. The owner/agent of the dog in question must prove such to the National Field Trial Secretary 2 weeks prior to the trial closing date.

**National Open Stake:** The National stakes must have at least 6 series, 5 on land and one in water. The dogs should run in pairs for at least 4 land series, but it is required that each dog competing must be paired with another dog in at least 2 of these series; in all 4 if possible. In no event may a dog not under judgement be used to create a pair. *CKC Sporting Spaniel Field Trial Rules & Regulations, Section* 12.5.1

**Water Test** - A Spaniel is primarily a land dog. However, in many parts of the country he is used to retrieve waterfowl, and in an ordinary day's shoot there are occasions when the only way of gathering shot game is after a swim or from a stream, pond or lake. *CKC Sporting Spaniel Field Trial Rules & Regulations, Section 16.3.5* 

**Points:** Championship Points are awarded for placements in the All-Age Stakes, provided that there are 12 or more starters. An all-age placement qualifies the dog to enter in the next two corresponding national field trial events: Points awarded as follows:

1st Place - 5 Points, 2nd Place - 3 Points, 3rd Place - 2 Points, 4th Place - 1 Point

## **Indignities and Unsportsmanlike Conduct:**

## **CKC Sporting Spaniel Field Trial Rules and Regulations:**

- 21.7 It shall be the duty and obligation of the trial-giving club to see that a judge, club official, field trial marshal, volunteer, gunner or competitor at a field trial held under these regulations, is not subject to indignities of any kind. The Field Trial Committee Chair **shall** promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue.
- 7.1 It shall be deemed unsportsmanlike conduct if a person during the running of or in connection with an event abuses or harasses a judge, trial official or any other person present in any capacity at the event.7.2 Any handler who displays unsportsmanlike conduct or who is seen to kick, strike or otherwise roughly manhandle a dog while on the grounds of a Spaniel field trial at any time during the holding of the event, may be expelled from the trial by the Spaniel Field Trial Committee.

### Non-member participation fee

- a) An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee.
- b) In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.
- c) The Premium List must carry a note stating that "these fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members".

Otherwise, please purchase bank drafts or money orders payable in Canadian funds. Personal cheques will be accepted, however they must be payable in US funds, and for the full amount of the entry.
